

Priority Pass, LoungeKey and Diners Club Usage Information

Cardholders who are paying for their own or a companion's stay should review and confirm the specific offerings against the charges.

Cardholders are advised to review the following conditions of entry prior to use.

① Upon using the service, our employees will confirm the following 2 details.

※Please note, that there are some changes from before.

● Expiration date of the card

Please present your Priority Pass membership card, credit card with LoungeKey function, digital membership for this service, or Diners Club card.

● Boarding Pass

Please present your Boarding Pass for your flight on the same day. ※It is within a restricted area, we ask for your cooperation in checking.

⚠ This service is applicable to both outbound and inbound passengers.

② Benefits of Use

- Cardholders are entitled to a discount of JPY 3,400 (incl. tax) as a member for lounge access.
- The discount of JPY 3,400 (incl. tax) can be used for all meals and beverages (limited to in-store dining).
- One discount of JPY 3,400 (incl. tax) is equivalent to one lounge visit for the cardholder's number of lounge visits. The fee for one visit to the lounge varies depending on the card. Please inquire with your credit card company.
- The cardholder may register up to 3 companions per visit.
Example: If the cardholder registers one companion, a discount of JPY 6,800 (incl. tax) will be applied to the final bill.

⚠ Depending on the conditions of use, the designated fee will be charged to the cardholder.

⚠ The reception only accepts 1 card per cardholder.

⚠ The discount of JPY 3,400 (incl. tax) is not transferable or exchangeable for cash.
Also, even if the final bill is less than JPY 3,400 (incl. tax) per person, the difference cannot be refunded.

⚠ If the total amount of the food and beverage bill exceeds JPY 3,400 (incl. tax), you will be charged for the difference.
No other discount services or coupons can be used for the payment of the price difference.

⚠ Each cardholder must present his or her card when used in a group.

⚠ If a customer who is not a cardholder accompanies you, they will be counted as a companion on a dedicated device.
It is generally not permitted to have guests who are not considered as companions.

⚠ However, if you do not share food and drinks, the person is permitted to accompany you, but please note that as soon as food and drinks are shared with one another, the person will be counted as your companion.

⚠ A person who is counted as a companion can receive a discount of JPY 3,400 (incl. tax) per person.

⚠ However, we are not able to confirm whether the accompanying person will be charged or not, so please check with your card provider or Priority Pass customer service in advance.

⚠ If the companion is under 7 years old, the cardholder may share a portion of their meal.
Please note that we may ask you to present an ID or certificate that proves the age of your companion.

⚠ This service is only available for in-store dining.
Please note that it cannot be used for light meals, takeout, or merchandise.

⚠ This service is not free of charge.
Please note that the terms and conditions of billing may vary depending on your credit card contract.

⚠ Our company is not aware of the terms of your contract or billing agreement.
Please contact your card provider, Priority Pass customer service, or LoungeKey customer service team if you have any questions.

⚠ Please note that services are subject to change without prior notice.
